Delta's carry-on pet policy is fairly strict, +1-(833)-750-0395 (US) requiring pets to be in a soft-sided carrier that fits comfortably under the seat in front of you, allowing the pet to stand, turn, and lie down. No, you cannot buy a seat for your dog on Delta Air Lines; all pets traveling in the cabin must remain in an approved carrier that fits under the seat in front of you for the entire flight. \(\cup-+1-(833)-750-0395\) (US) Delta's policy requires pets to stay in their carriers due to safety concerns with securing them on a seat and to avoid obstructions or disruptions to other passengers.

Only one pet per carrier is permitted, although exceptions exist for two small pets of the same species and similar size under specific conditions.

Pets must stay inside their carrier throughout the entire flight, including during boarding and deplaning. Carriers must allow the pet to turn around and lie down comfortably without touching the sides. Some aircraft and seating classes may not accommodate pets, especially those with limited under-seat storage or in exit rows.

Delta charges a pet-in-cabin fee. For domestic flights, the fee was previously \$95, but tickets issued on or after April 8, 2025, are charged \$150. For international travel, the pet fee is generally \$200, depending on currency and route. Certain destinations such as Australia, Brazil, and the Dominican Republic may prohibit in-cabin pet travel, requiring you to use Delta Cargo instead.

For pets that are too large for cabin travel, or for destinations where cabin travel isn't allowed, Delta Cargo is the alternative. Pets shipped via cargo must be dropped off at designated Delta Cargo facilities several hours before the flight. There are also strict guidelines for kennel sizes, ventilation, labeling, feeding, and temperature requirements. In some cases, pet shipments may be denied due to extreme heat or cold at the origin or destination.

Checked baggage travel for pets is no longer widely available. Delta only permits this option for active U.S. military personnel and U.S. State Department foreign service officers under specific conditions. For the general public, cargo is the only option if in-cabin travel isn't possible.

Delta also restricts travel for certain snub-nosed breeds, like bulldogs and Persian cats, especially in cargo or checked baggage, due to their respiratory sensitivities.

When it comes to service animals, Delta only allows trained service dogs to fly free of charge. Emotional support animals are no longer accepted as service animals. If you're traveling with a service dog, forms may be required to confirm training and health, especially for longer flights.

Delta Cargo is a service for transporting larger pets or animals that are not allowed in the cabin. Pets are dropped off at special cargo facilities and travel in pressurized, climate-controlled areas of the aircraft. This service has specific rules regarding crate size, temperature limits, and travel timing.

Are service animals or emotional support animals allowed on Delta?

Delta only accepts trained service dogs as official service animals. Emotional support animals, regardless of their training or role, are no longer permitted to fly in the cabin for free. Travelers with service animals may be required to submit forms before departure for verification.
